Normal rains with no major storms kept the dam level within 4" of boards. Dam not re-opened for spring.

## **Water Quality Report**

The water quality report was presented by Jay Van Tassell. His report indicated that this year we had a reading of 4.6 meters. Water quality monitoring data have been collected from Bunganut Pond since 1974. The reading averages are:

Min 2.7 meters in depth

Average 4.2 meters Maximum 5.9 meters

It was recommended to continue to be cautious of erosion and the use of fertilizers close to the water. This fine sediment washing into the pod has an adverse affect on the water quality.

Charlie Kokernak brought up a recent article in The Portland Press Herald which stated that 36 of the 260 lakes in Maine are affected by invasive weeds. It was suggested that people continue to monitor all boats and water craft entering the pond to be certain no weeds are present. An additional warning was issued by Chuck Shaw regarding fishing tackle which has been shown to be a carrier of the invasive weeds.

#### **New Business**

Special thanks were extended to Jay Van Tassell for printing the meeting notices and to Mrs. C's Bakery for the fresh pastries.

#### **Election of Officers**

Jan Van Tassell indicated that he wanted to step down as a director. The board thanked Jan for all of the work he has done for the association and the lake property owners.
